In continuation of MoD letter of even No. dated 27th February 2013 letters of even number dated 01st May 2015 and 08th August, 2016 were subsequently issued, on the subject mentioned above with the approval of Ministry of Finance (Deptt of Expenditure). As the Model RRs for various posts of Draughtsman Cadre have now been issued by DoP&T vide letter No. AB-14017/7/2013-Estt(RR) dated 09th January, 2017, the designation of Draughtsman Cadre in Defence Establishments may be kept as per the Model RRs, which is as under:
