


Subject : Implementation of recommendations of 7th CPC – Issue of "Civilians in Defence Services (Revised Pay) Rules, 2016" and other circulars

Ministry of Defence has issued "Civilians in Defence Services(Revised Pay) Rules, 2016" on 9th Aug 2016 and the same has been uploaded on the website of MoD (Department of Defence). It is requested that the concerned Lower Formations/ Line Directorates/ Organisations under the control of various Administrative Divisions of MoD may be advised to download the same from the website (<http://mod.gov.in/writereaddata/cdsenglish2016.pdf>) for further necessary action. It is clarified that the copies of the CDS (Revised Pay) Rules, 2016 shall not be circulated separately to all the Administrative Divisions/Lower Formations.

2. In order to facilitate quick communication and to promote paper-less office practice, all circulars/ communications on the subject are being uploaded by this office on the MoD (Deptt of Defence) website under the link "**Employees' Corner**" in a separate section with the title "**Seventh Central Pay Commission**". All concerned are requested to access this link to know the status of newly issued communications on the subject of 7th CPC. It is reiterated that the copies of various Circulars/Orders on this subject will not be circulated/ despatched separately.

All Divisional Heads of MoD are also requested to issue firm directions to all concerned Lower formations/Line Directorates/Organisations under their administrative control to ensure that payment of arrears on account of revised pay w.e.f. 1.1.2016 is paid in cash in one instalment, along with the payment of salary for the month of August, 2016, in terms of instructions contained in para 7 of the MoF OM No.1-5/2016-IC dated 29 July 2016 (also available on MoDs website for ready reference).
